Minutes -

- One correction/addition
 - Diane and Emma Pust were on the last conference call.
- Karissa motioned to accept the February 8, 2015 conference call minutes with the corrections/additions. Kathy seconded the motion.
- No discussion.
- Vote: 13 Yes, 0 No, 0 Abstain. Motion passed.

Treasurer Report -

- Reports were sent out prior to the meeting.
- Need sponsorships.
- OR and WA district money coming in. One WA district is sending in an additional \$500 for sponsorship of Large Drill.
- Last year had most sponsorships in hand by now.
- Concerned about bottom line not a lot of wiggle room.
- The patches (both rockers for 2014 & 2015 and PNWIC patches) will be about \$1200.
- Did everyone receive the sponsorship letter? Yes.
- Kathy will follow up with WA family who had access to shavings.

Old Business

Facility -

- Shavings and Stalls
 - o Bulk shavings will be about \$40 per athlete this includes disposal.
 - Bag shavings are \$6.25 per bag. We would charge athlete \$9 this would include disposal.



- \$100 was what was said we would charge the athlete this included the stall and bedding.
- O How are we going to charge for shavings?
- o Does PNWIC "eat" the cost of those extra shavings that the athlete needs?
 - Most agreed that a stall should come with at least 2 bags of shavings.
- Athletes can purchase extra shavings if needed.
- o We need to adjust the budget for the cost of stalls and bedding.
- Athletes will have to purchase shavings at the fairgrounds can't bring own.
 - This is because we have to charge for the disposal of all shavings, so need to know how many are being used.
- o How many/much shavings did we use last year?
 - We had some left over from OR state meet.
 - Used OR Willamette district as an example (they have to purchase shavings and pay for disposal) and increased that amount for tax.
 - \$11,000 budget includes stall rental need to separate out.
- Need to come up with how many/much shavings to provide each athlete.
- Disposal is by the square yard.
- Contract with facility states that we can't bring in shavings have to use what they
 provide. They need to keep track of them.
- According to budget
 - \$33,000 is income for stalls and bedding.
 - \$4500 is income for tack stalls and extra horse stalls.
- Extra stalls had to be ordered for last year. There is not enough in budget for extra stalls if needed.
- Need a cost break down from last year and numbers.
- Denise needs a copy of the signed contract.
- o Kathy and Sonya need to talk about this with the fairground facility.

Awards –

- All awards have been ordered.
- Buckles done.
- 2nd and 3rd place awards will be trophy items for the house or barn.
- Under \$500 not covered yet.
- Budget is for \$9200. Will be close. Will be under budget.

Budget -

- Last year stalls were:
 - 350 stalls @ \$100 per stall = \$35,000.
- This year:
 - 14,000 stall days @ \$16 per day = \$22,400.
 - o 700 bags of shavings (2 per athlete) @ \$9.25 = \$6475.
 - Total budget for stalls/bedding should be \$28,875.
- Budget needs to be revised to state the above for this year.
- Tack stalls are a flat rate of \$16.
- Stalls are \$16 per day.
- Need to split out horse stalls, tack stalls, and extra stalls on registration form.





- Who has a copy of the signed contract?
 - Karissa will email out a copy.
- Kathy and Sonya need to talk about facility and contact issues.
 - Agreed to talk tomorrow (3-16-2015) and also make contact with fairgrounds facility.

Schedule -

- Has been approved.
- Needs to be changed to Team Sorting (not penning).
- Was sent out to committee members.
- Is up on both OR and WA website links to PNWIC.
- Cows will be coming in on Saturday not Friday.

Rules Changes -

Only one is OR alternate for 2-man teams.

Cattle -

- Have contacted 3 vendors on the west side (WA).
- Two have prior commitments.
- The one vendor can supply cattle for \$1750 for the meet.
- Will be 34 head of cattle.
- Vendor is Kenny Stone Cows R' Us.
- Will need to overnight the cattle at the facility.
- Will be bringing a couple of workers.
- This vendor does most of the WA meets.
- WA uses horned cattle.
 - O WA rules are no more than 2". Same as OR.
- Will follow WA rules for horned cattle.
- Does the facility charge for pens? Overnighting of the cattle?
 - Not sure. During walk thru gentleman didn't seem to think we would be charged. But need to check.
- Will the cattle provider be there overnight?
- Can we set up panels or do the facility workers have to do this?
- Will need to get a contract from the vendor.
- What if we bring more teams/individuals for cattle events will it cost more? No.
- Adam motioned to approve Kenny Stone with Cows R' Us as our cattle provider for the PNWIC meet. Karissa seconded the motion.
